Science in the Pub Series: Orsolya Molnár, Evolutionary Biologist: Covid-19 and the DAMA Protocol

COVID-19 and the DAMA Protocol the latest Science in the PubTopic

The COVID-19 epidemic has sensitized the public to the fact that climate change may lead to the emergence of unforeseen diseases and the re-emergence of others. Increased human activity, mass travel, and rapid urbanization cause significant health, economic and social damage as pathogens are transferred from animal to humans or infect other species. Dr. Orsolya Molnár, a researcher at the Ecological Research Center, spoke on this topic and the current state of research in the most recent iASK series of public lectures. The central theme of the presentation was the DAMA Protocol that addresses the serious challenge to identify and manage potential threats at an early stage. The DAMA Protocol was developed jointly by Hungarian and American research fellows at iASK and informed the Hungarian government's response to the crisis.

Lethal Solidarity

András Nagy

The book is based on several decades of archival and historical research on what happened and why after the 1956 Hungarian Revolution at the UN and beyond. Documents classified for 60+ years recently became accessible and reveal the background of clashes between secret services, the pragmatism of the great powers, the involvement of cynics and of fanatics. The story of the Danish diplomat Povl Bang-Jensen is also told, as he gave his life trying to solve the "Hungarian Question" and the illusion that many people nurtured about the role of the UN and its principles.

Natural and Artificial Intelligence

György Csepeli

Can artificial intelligence, which has developed rapidly in the 21st century, merge with human intelligence and be able to reproduce itself without human intervention? If yes, the real question is whether the intelligence of a potential superhuman will be sufficient to adapt to the changes that threaten the human race in its very existence. For the author, human existence is far more than an intelligence problem, because empirically graspable, algorithmic problems, say nothing about what is good, what is evil, or what is the meaning of life. Quoting E. Hankiss: one can only survive in the world if one believes and trusts in a common enterprise for a spiritual and cultural place in the material world. The conclusion is that artificial intelligence cannot replace human perseverance and creativity that allow humankind to transcend what is visible to see truth in its totality.

Complexity in Nature and Society From Dancing Molecules to Collapsing Societies Dezső Boda

What is common in complex systems in nature and society? The book presents, in a popular format, how simple rules control the behavior of the agents that constitute the system which, in turn, leads to an emergent behavior in the whole system.

Pannonian Values - the Jewish Community of Körmend Edit Szántó

The results of the author's previous and most recent research on the history of the city of Körmend's Jewry enriches the literature on the history of Western Hungary. She presents the history of the Jewish community in the typical market town of Körmend protected by the aristocratic Batthyány family, the community's significance in the economic life of the town, she traces the origin of nationally and internationally renowned scientists and artists who started their careers in Körmend, and finally traces the events that led to the total annihilation of the community.

Central Europe from a Hungarian Point of View in 2020

Bába Iván – Gyurcsík Iván – Kiss Gy. Csaba:

Three noted authors review serious issues like the "bumpy road" from the end of the Cold War to the era of integration, the question of borders, the oppressive shadow of large neighbors, nationalism, the role of religion, and migration. This is a work by committed Central Europeans, written on a liberal ideological basis, and a response that to book by Emil Brix and Erhard Busek, *Mitteleuropa Revisited: Warum Europas Zukunft in Mitteleuropa entschieden wird* [Rethinking Central Europe: Will the Future of Europe be Decided in Central Europe?].
